Most of the 138,000 people with IDD in NYS served by OPWDD live with the parent caregiver.

48%	caregiving involves help with "almost all basic activities"
86%	caregivers are parents (54% are single parents)
62%	caregivers are themselves experiencing health issues
46%	caregivers are over the age of 60

More than 1000 people in NYS with developmental disabilities known by OPWDD are in immediate need for housing!

The state serves the remaining 13%.

Yet, nonprofits receive only 50% of the total dollars intended for services.

Did you know...?

The people caring for individuals with IDD are referred to as Direct Support Professionals ~DSP.

The average salary of a DSP is \$12.74/hour Starting wage at Macys = \$13.43 Starting wage at Walmart = \$14.00 Starting wage at Whole Foods = \$14.97 source:Indeed.com/

DSP responsibilities include: daily hygiene, grooming, feeding, supervision, medication administration, lifting, bathing, transporting, teaching, helping, protecting, guiding. A DSP is a friend, protector, mentor, companion, caregiver, coach.
